# **5 Fire Fighting Measures**

#### **Suitable Extinguishing Media:**

Stop leak if safe to do so and absorb spill with sand, earth, vermiculite or some other absorbent material. Collect the spilled material and place into a suitable container for disposal. Rinse the spill area with plenty of water.
